The chapel, when fully restored, will be used as a community center for events and exhibits highlighting the central role East Boston had (and continues to have) in welcoming immigrants to the United States. (NOTE: \$201,541 restoration expenses were capitalized pending completion of the project when the chapel/community center is put in service.)
