EDUCATION - AFRICA FOUNDATION (USA) MAKES THE BUILDING AND IMPROVEMENT OF PRESCHOOLS, PRIMARY SCHOOLS, AND HIGH SCHOOLS A PRIORITY BELIEVING THAT THROUGH EDUCATION, RURAL PEOPLE CAN BREAK THE CYCLE OF POVERTY. FUNDS WERE DISTRIBUTED TO CLASSROOMS, KITCHENS AND FACILITIES PROJECTS IN SOUTH AFRICA (\$78,750), TANZANIA (\$112,714), KENYA (\$96,491), AND NAMIBIA (\$20,000).

AFRICA FOUNDATION (USA) HELPED FUND THE COMMUNITY LEADERS EDUCATION FUND (CLEF) (\$45,450). THIS BURSARY PROGRAM HAS THE GOAL OF EMPOWERING COMMUNITIES BY BUILDING LEADERSHIP AND ENABLING INDIVIDUALS TO REALIZE THEIR DREAMS. THE PROGRAM HAS TWO COMPONENTS, THE ACADEMIC SPONSORSHIP AND THE REQUIREMENT OF THE RECIPIENT THAT THEY SHARE THEIR NEWLY ACQUIRED KNOWLEDGE AND SKILLS WITH THEIR COMMUNITIES.
