BREAD OF LIFE CONDUCTS MONTHLY FOOD DISTRIBUTIONS BY GIVING GROCERIES ON THE 3RD SATURDAY OF EACH MONTH AT 5 DIFFERENT FACILITIES (STOCKTON - 2, LODI, TRACY, & MANTECA). IN 2017 THEY WERE ABLE TO GIVE GROCERIES, TOILETRIES, AND OTHER ASSISTANCE TO OVER 3000 INDIVIDUALS, MANY OF WHOM RECEIVED GROCERIES MULTIPLE MONTHS DURING THE YEAR. DURING THE DECEMBER GIVE-AWAY, TOYS WERE GIVEN TO ANY CHILDREN WHO CAME TO THE SITES. BREAD OF LIFE ALSO PROVIDED MONTHLY GROCERIES TO STUDENTS' FAMILIES THAT PARTICIPATE IN AN AFTER-SCHOOL PROGRAM AT A LOW INCOME SCHOOL, A SINGLE MOMS GROUP, AND A HOMELESS CAMP.
