FOUNDED IN 1882, MULTICARE IS THE LARGEST PROVIDER OF HEALTH CARE SERVICES IN THE CITY OF TACOMA, AS WELL AS PIERCE COUNTY, KITSAP COUNTY, THURSTON COUNTY, AND SOUTHERN KING COUNTY. MULTICARE IS NOTED FOR ITS UPDATED FACILITIES, STATE-OF-THE-ART TECHNOLOGY, SAFETY RECORD AND FOCUS ON QUALITY CARE.
