Community Engagement - Powerful Voices works within the community on girls' issues to promote equity and make the world a just place for everyone. Community Engagement efforts include producing the annual Girlvolution Conference, providing training on Powerful Voices curriculum and practices, serving on coalitions and partnering to provide outreach to girls detained in King County Juvenile Detention. In 2017, the Girlvolution Conference reached over 320 youth and adult allies. Powerful Voices provided training to 34 other youth development professionals and adults and trained supported 11 new Adult Allies (mentors) and served on various community coalitions. Powerful Voices staff facilitated education and socio-emotional workshops with 27 girls in detention.

Form 990, Part III, Line 4b:

Powerful Choices - Provides girls with education and pro-social activities to promote positive identity, promote healthy relationships and tools to access community resources. The curriculum is delivered through group and individual sessions. Powerful Choices was offered in three Seattle Public Schools middle schools, reaching 31 youth. In partnership with other community organizations such as Atlantic Street Center, Community for Youth, Children's Home Society, we served an additional 48 girls.

Form 990, Part III, Line 4c:

Youth Employment Program - Provides girls with pre-employment, career building and job readiness skills. Three cohorts of girls participated in a group employment program that includes individual goal setting and performance evaluation session. The first cohort is Develop Your Voice and Speak (DYVAS), where young women are employed to produce an alternate form of media to educate the community about social justice issues. The second cohort is ActiveVistas, where young women are employed to develop and present workshops at the Girlvolution Conference. The third cohort is Job readiness focused on developing real-world skills through activities such as career panels, resume assistance, mock interviews. The Youth Employment program served 27 youth.
