YAKIMA TRIBUTARY ACCESS AND HABITAT PROGRAM (YTAHP) HAS THE GOAL OF INCREASING SAFE ACCESS OF SALMON TO TRIBUTARIES IN THE YAKIMA BASIN THAT THEY HISTORICALLY USED FOR SPAWNING. WE DO THIS BY WORKING WITH CONSERVATION ENTITIES ACROSS THE YAKIMA BASIN TO IDENTIFY AND PRIORITIZE PROJECTS THAT INCLUDE THE REMOVAL OR REPLACEMENT OF HUMAN MADE BARRIERS, SCREENING IRRIGATION DIVERSIONS AND IRRIGATION DIVERSION IMPROVEMENTS AND REMOVAL OR IMPROVEMENT OF OTHER PASSAGE OBSTACLES. The grant covered expenses of WA FAC LN starting late November 2014. The WA FAC LN addresses Wildland Urban Interface issues, programs and assistance to connect and empower communities to create fire adapted communities and landscapes. The US Bureau of Land Management is supporting continued work for this project with a cooperative agreement. The communities implemented innovative fire adapted communities programs and shared what they learned throughout the network. RC&D will continue this project through 2017 into 2020.
