It is also too complex and time consuming for our volunteers to figure out how to refurbish and recapture value for use in our programs that serve the indigent. Thus we work with Panland Global, which accepts this equipment, refurbishes it, and provides the WTA with 90% of the recaptured value which we utilize in our programs that serve the indigent. If we did not do this, our only other alternative would be to recycle it, which would not benefit the environment, or our non-profit, or the indigent people we serve.
