<p>28 Personal networks formed around a focus person with disabilities, designed to create safety and security and ideally continue for the lifetime of the person with disabilities, after parents are gone. There are 17 networks with a focus person at center, quarterly meetings, with approximately 10 members per network. Workshops & trainings for families. In 2017 a meeting was held for the LifeSPAN community. A total of 20 participants attended the day-long meeting in July to assess our needs as a community and plan for the future. We held 2 Stone Soup & Social gatherings to facilitate networking & learning (about 10-20 participants at each meeting). Additional outreach included a "Facing the Future Together Succession Planning Workshop", which had 15 participants, and a pilot workshop entitled "Personal Safety Nets for Families Supporting Loved Ones with a Disability", which had 4 participants. The Future Planning Consultation is a process that helps a family review the current state of affairs pertaining to their relative with a disability and options for the future. In 2017 we did not conduct a consultation. LifeSPAN also sponsors informal events for member families as well as the broader community, designed to strengthen our organization and provide more opportunities for friendship and relationship to grow.
