1) C.A.R.E. Baboon Sanctuary is located in the Limpopo Province of South Africa. While they accept any animal in need, the sanctuary was established in 1989 with an emphasis on the chacma baboon. Currently they house over 400 baboons and are the largest sanctuary in South Africa dedicated to orphaned, injured, abused or abandoned baboons. The sanctuary also offers refuge to baboons who have been confiscated or released from laboratories, many of whom have severe problems. Volunteers assist in all aspects of the daily work at C.A.R.E. including the preparation of food and bottles and feeding the baboons. In addition the volunteers provide round-the-clock care and nurture for the infant baboons, administer medications, assist in the research and record maintenance on the behavior of these baboons. Approximately 30 volunteers from the Lion Foundation assisted C.A.R.E. in 2017.

2) The Siyafunda Research Camp is located in the 61,000 acre Makalali Game Reserve near Hoedspruit, South Africa. In 2017 there were 2 major research projects undertaken by Siyafunda: the Elephant Contraception Project and the Lion/Predator Project. The Elephant Contraception Project and the Lion/Predator Project. The Elephant Contraception Project is a program designed to safely control the growth of the populations of elephants in South Africa and has been extremely successful in the last few years. The volunteers provide valuable assistance by maintaining records and continually observing and monitoring behaviors of the cows who have received the vaccine. Over 120 volunteers from the Lion Foundation assisted Siyafunda Research group in 2017.
