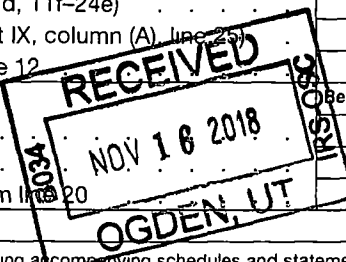

ABG is a northern latitude, organically maintained botanical garden with display gardens, interpretive nature trails, educational programs for youth and adults, recreational events and a research program. Professional horticulturists maintain a permanent plant collection using an accession data management system. Professional educators implement an intensive, year-long, afterschool program using nutrition, botany and horticulture to teach STEM to low-income Anchorage School District students in extensive in-school and field trip programming. ABG also teaches adult learners through workshops and courses offered throughout the year. ABG supports a visitor program reaching an estimated 35,000 visitors annually. In addition, ABG collaborates with partners on regionally appropriate research projects. See Part III, Ln 4a statement
