The organization conducted multiple runs and walks in 2017 that were open to the general public. The majority of the events were timed. The events ranged in size from approximately 100 participants to approximately 2,600 participants. The focus of all events was to promote running and walking for fitness, fun, health and overall quality of life.

The organization produced a monthly newsletter that was distributed via email and online, along with a printed publication called "The Oregon Distance Runner" that was issued quarterly during the year. The online newsletters and printed publications highlighted events available for individual participation by the general public, had many health and fitness articles and information, and had articles of interest to runners and walkers concerning running, walking, road racing and general fitness

The organization conducted weekly training runs that are open for no cost to the general public. The organization also promotes programs that encourage regular running and walking for fitness.
