FRESNO, CALIFORNIA //MARCH 25 - APRIL 2, 2017 God moved in mighty ways in Fresno this year as Luis, Andrew, and the entire team joined with nearly 300 local churches and non-profit organizations to accomplish one of the largest collaboration efforts the city has ever seen After more than two years of preparation, planning, and prayer, Fresno CityFest culminated at Save Mart Center where thousands of people heard the Good News from Luis, Andrew and dozens of musicians and friends In the week leading up to the 2-day festival, Luis, Andrew, and the team helped lead several outreaches throughout the Valley, including 17 prison outreaches, a luncheon for women, a gathering for business and civic leaders, a college outreach event, and a mini festival for the Latino community in the city of Reedley In total, more than 45,000 people were reached through more than 50 events and more than 3,000 people documented a confession of faith in Jesus Christ Each decision-maker is now being invested in by a local participating church Also as part of the campaign, Fresno CityServe helped to unify multiple service agency and gather thousands of individuals to serve the valley through more than 1,100 service projects and 145,000 volunteer hours Fresno CityFest also hosted an Extend the Impact Conference including more than 25 partner evangelists and their spouses from seven states There were also delegates from a handful of cities who came out to observe the festival as they consider inviting the Palau Association to help with similar citywide campaigns Our heart is that the unity established through Fresno CityFest continues for years to come, encouraging more citywide outreach efforts and ongoing service initiatives throughout the valley

Form 990, Part III, Line 4b:

GUATEMALA CITY, GUATEMALA //MARCH 2017 Guatemala Festival was a great success, although it was not without its challenges. Amid much unrest and very active political protesting, the Good News was proclaimed clearly and powerfully. More than 35,000 people were in attendance for the one-day festival in the heart of the city, right in the shadows of the presidential palace. Tens of thousands more tuned in to the live, international television broadcast via Enlace TV. In the end, more than 1,300 people made public confessions of faith in Jesus at the festival and are now being followed up by local churches. It was a battle for sure. The devil did not want the festival to happen. There were many distractions throughout the night. Opposition at times right in our faces in the midst of Luis' message. Protestors yelling. Fireworks set off to draw attention away from the message. Yet the team stood strong and the Lord was glorified. During his time in Guatemala, Luis was invited to meet with President Morales. Just 10 days after a horrific fire tragically took the lives of 40 young girls living in a government-run shelter, Luis offered his insight and encouragement as the nation mourned the loss of these children. During the private meeting, Luis offered his deepest sympathy to the people of Guatemala, especially the families directly affected by the tragedy, and reminded the president that the evangelical community was praying for the nation during this time. "This is a difficult time for the nation of Guatemala. Many people are hurting. Many families are suffering. Many people are asking deep, fundamental questions," said Palau. "What better time for us to lift up the name of Jesus Christ and remind the nation about his hope, his sacrifice, his love, and his peace even in the midst of this pain and loss." Luis was also honored by the leadership at Universidad Mariano Galvez, one of the largest and most respected universities in the nation with 94,000 students. He also gathered with hundreds of local pastors and church leaders to encourage them in their role within society and their responsibility toward the community. Luis has a long history of ministry in Guatemala, first visiting the nation in the early 1970s. His most memorable visit came in 1982 when he spoke to more than 700,000 people at a one-day gathering in Campo Marte. That gathering is thought by many to not only be one of the largest gatherings in Guatemala's history, but one of the largest gatherings of evangelical Christians in all of Latin America.

LA MATANZA & LAS MALVINAS, ARGENTINA //NOVEMBER 11-19 Over the past 40 years, God has used the Palau Association to bless the nation of Argentina in powerful ways. From the historic festival in the capital city of Buenos Aires in 2008 to similar festivals and outreaches in the nearly every province and major city of the nation, millions of individuals have heard the Good News presented by Luis and Andrew. In an ongoing effort to reach more people with the Gospel, Andrew partnered with churches for a 2-day festival in La Matanza (pop. 2 million) and another festival in Malvinas Argentinas (pop. 320,000) for two festivals this fall. Our team hosted evangelistic gatherings with business and civic leaders in both cities, in-depth training for thousands of believers, training conferences for pastors, church leaders and evangelists, building upon the wonderful partnerships already established in this region. God used our team to reach thousands of people with the Gospel.

INSTITUTO BBLICO LUIS PALAU //TEACHING AND TRAINING IN LATIN AMERICAThe Luis Palau Association has spent the past seven years developing and launching a powerful online training curriculum designed specifically for Spanish-speaking pastors and church leaders. Working with several strategic partners--including Enlace Television, Logos University of Florida, and several well-known Christian leaders--the Insituto Bblico launched in 2010 and has grown to become a valuable training resource for pastors and leaders throughout Latin America and the Spanish-speaking world. The Spanish Bible Institute now offers more than 120 training hours that maximize five decades of ministry experience from more than 25 top Christian leaders, all free of charge. As of December 2017, more than 45,000 Spanish speakers have gone through the online training course with more than 40,000 still actively participating in ongoing training. 8,100 students are actively connected to our exclusive Facebook group (only made available to students of the Spanish Bible Institute). Countries with the most participants include Mexico, Argentina, Colombia, and the United States, yet we have more than 50 countries represented in our student enrollment. In studying the students who are registered we found that some 35% to 40% are women leaders and wives of pastors. And as we do not have anything specifically for women at this level of leadership, we have begun development of a new section that will be called "From woman to woman." This new section will be distinctive in that it will have teachings specifically about subjects of interest to women and will be taught by women who are professionals in the areas they are teaching.

MEDIA MINISTRY //Proclaiming the Good News through MediaToday represents a new day for proclaiming the Good News, uniting the Church, and impacting cities worldwide through media, breaking the stereotypes of Christian programming and publications and leading the way through innovative evangelistic endeavors. For more than 40 years the Palau Association's evangelistic radio broadcasts have been one of the broadest-reaching areas of the ministry. Heard by millions of individuals on more than 5,500 radio outlets in 48 countries, Luis and Andrew provide listeners with practical encouragement for sharing God's love, in-depth Bible teaching, and answers to deep spiritual questions. As new media opportunities continue to present themselves around the world, including television specials and new social media efforts, we are capitalizing on the open doors, using each occasion to clearly share the life-changing message of Jesus Christ. From historic book releases in China to international television specials across Latin America, from worldwide daily radio programs in both English and Spanish to innovative Internet outreaches spanning continents, the Lord is using our media efforts to reach millions of individuals in a personal and powerful way.

COTE D'IVOIRE, AFRICA //OCTOBER 23 NOVEMBER 5 As part of a ten-year campaign to saturate Africa with the Good News of Jesus Christ, Andrew joined hundreds of churches and thousands in believers in Cote d'Ivoire (Ivory Coast) and held a multi-year, multi-city, interdenominational evangelistic campaign While the focus of the campaign is on the nation's two capital cities, the Palau Association mobilized several of its Next Generation Alliance (NGA) partner evangelists to reach other cities in Cote d'Ivoire in an effort to reach the entire nation with the Gospel In San Pedro, for example, a four-day festival featuring NGA Evangelists Richard Hamlet, Allan Greene, Reid Saunders, and Keith Cook drew 47,000 people in attendance and resulted in 5,251 public confessions of faith In Yamoussoukro and San Pedro, each decision maker received a Gospel of John (more than 100,000 were distributed in partnership with Bibles for the World) and will be followed up by the local church and one of the 2,346 "friends of the festival" who were trained in evangelism as part of the campaign To conclude his time in Cote d'Ivoire, Palau met with 100 church leaders and denominational heads in Abidjan to report on the work in Yamoussoukro and begin the planning for Abidjan efforts For the Palau Association, this year marks the launch of a massive, four-year initiative called "2020 Bless the Nations " The effort sets to expand ministry in every aspect by building the largest global network of evangelists, increasing capacity for citywide evangelistic efforts, helping to foster City Gospel Movements across the world, and broadening the overall global reach of the Gospel through new media opportunities The four-year push sets to culminate in a massive year of proclamation in the year 2020 God willing, this will feed into even great evangelistic opportunities in 2018 as we focus on the larger, economic capital of the nation, Abidjan (population 4.7 million)

This book allows many more people to learn the profound truth behind Christmas and get answers to their deep, eternal questions.
