Thru educational & outreach initiatives, BUF increases awareness to social, economic & cultural significance of philanthropy, builds the capacity of individuals to give & encourage greater philanthropic awareness. During the year ended December 31, 2017, 14,356 people benefited from grants & allocations; 11 agencies received grants.
