During summer months when students don't have access to their school libraries, McMinnville Public Library is reaching out with its bookmobile to bring books and activities to underserved neighborhoods. The children are excited to meet the bookmobile when it comes, receiving free books, borrowing books, participating in STEAM (science, technology, engineering, arts and math) projects, and maintaining their energy with healthy snacks. The team offering these services comprises both paid library staff and volunteers. Funding for this program comes from the Foundation's annual fundraising letter. Foundation assistance includes paying for personnel and supplies costs. The board has made Book Buddies an ongoing part of its support for the library, as it does with Collection Enhancement.

For 2017, Book Buddies took the bookmobile to three different neighborhoods once a week for 11 weeks, six hours per visit. This outreach served 1006 program participants and 741 bookmobile visitors.
