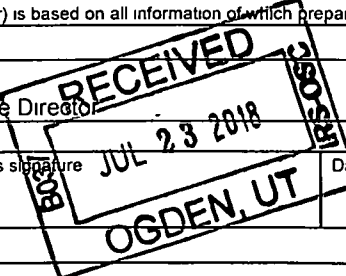

The Gender Justice Program addresses sexism, heterosexism, transgender oppression, reproductive justice, and family security in the context of racial and economic justice. We develop tools, resources and analysis and provide training and organizational support to help groups and their constituencies advance policies and change hearts and minds. We are BRAVE (Building Reproductive Autonomy and Voices for Equity) works with organizations of color to prevent further weakening of family security and self-determination while being more proactive in achieving reproductive justice. In 2017 We are BRAVE accomplished its key policy victory, passage of the Reproductive Health Equity Act (HB 3391 or RHEA), which expands coverage and secures access to reproductive health care for any Oregonian regardless of income, citizenship status, or gender identity. While no victory is achieved alone, BRAVE's work from 2013-2016 laid critical groundwork which made this policy. During this period, BRAVE worked with five organizations based in communities of color to identify policy and culture change

Leadership Development is woven throughout all of our programs at the Center. In 2017 we completed our 11th class of WILD (Western Institute for Leadership Development), which began in June 2016 and ended in August 2017. The program provided leadership and skills training to 14 leaders over four trainings, with a graduation ceremony at AMP. Five workshops at AMP were led by nine of these program participants, reaching over 100 workshop attendees on topics such as police profiling, building white allyship against racism, and rural organizing. Our stand-alone leadership development conference AMP (Activists Mobilizing for Power) returned in 2017. From August 11th - 13th, 562 participants from 19 states, and 253 organizations, attended at least one workshop. The majority of participants were from six states: Idaho, Montana, Nevada, Oregon, Washington, and Wyoming. The conference was also a meeting point for the final session of WILD, a special regional summit of leaders from across the West to discuss strategies to counter white nationalism, and a series of cultural events, including a

The Racial Justice Program supports organizations building power in communities of color, immigrant and refugee groups and communities in addressing vital racial justice issues. The program also supports organizational development work to include racial equity. In 2017, we interviewed 12 organizations around the West that have Racial Justice as an intentional and integrated part of their work, to ask what support they need to advance their Racial Justice goals. We also organized three meetings in Oregon to respond to the increased activism by white nationalists. We are exploring the Center's ability to take on this work in 2018
