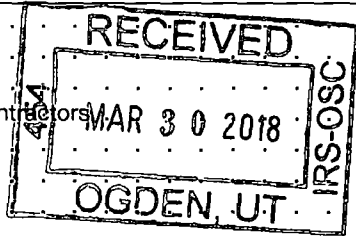

Matale, Uganda: Girls Dormitory Project - Construction of the girls dormitory at St. Andrews Matale Secondary School. The dormitory will house 300 girls, many of them orphans and reduce the safety risks for these students that typically walk 3 to 6 miles daily to attend the school. Living in a dormitory safe environment will allow these students to focus on their studies.

Sister School programs connect schools in the U.S. and schools in Africa.
