28 Project H E R This program continued to provide free health services (Help, Enlightenment, and Resources) in Benton, Linn and Lincoln counties of Oregon The Navigator program was expanded in 2017 to support patients, including men, with all types of cancer The program provides awareness, education and support for patients from the time of cancer diagnosis through survivorship, with the Navigator team, which consists of a nurse navigator, outreach coordinator, and cancer survivors who mentor patients free of charge with the guidance of the nurse navigator Project H E R added 82 new patients in 2017 and served a total of 740 patients There were 17 active mentors during the year The program started a private Facebook group for female cancer survivors in the community and a monthly e-newsletter The MammaCare program's nurses and clinicians provided a breast/cervical cancer screening event that served 36 patients The Cook for Cancer program provided 216 meals, or 864 servings, for families of patients who were undergoing chemotherapy treatments of all types of cancer diagnoses, oncology and hematology Project H E R nurses and clinicians also participated in other outreach events to increase awareness of breast cancer prevention and Project H E R support, including (1) facilitation of "Look Good Feel Better" classes through the American Cancer Society, (2) partnership with Pink Sistas, Inc to provide a breast cancer retreat (attended by 8 women), (3) sponsorship and tabling at the Soroptimist International Walk for the Cause event, (4) sponsorship and attendance at the annual local Soroptimist International tea and auction, and (5) support at numerous Dam Cancer (Pink Out) athletic events held at the local university and high schools In addition to \$49,648 of cash expenditures paid for programming and outreach (which includes \$41,067 paid for a leased employee and \$1,000 for grants), \$72,749 of donated meals, services and facilities were received in 2017 for Project H E R programs (Grants \$ 1,000) If this amount includes foreign grants, check here . . . ☐	28a	49,648
