Facts And Circumstances Test

Current Year Facts and Circumstances The Organization did not meet the 33 1/3 percent-of-support test required of a charitable organization in the tax years subsequent to 2005. The Organization ceased its active operations effective October 1, 2017, closing its offices and thrift shop and terminating its employees other than a part-time interim administrator hired to assist with the winding down of operations. Effective October 1, 2017, the Organization entered into a Grant Agreement with Peace of Mind Dog Rescue (EIN 27-1154816) for this Section 501(c)(3) organization to operate the programs previously operated by the Organization and provided a grant to Peace of Mind Dog Rescue in the amount of \$72,000. The Organization anticipates that, in 2018, it will transfer substantially all of its remaining assets to Community Foundation for Monterey County (EIN 94-1615897) with a view to dissolving in July 2019.

Prior Year Facts and Circumstances The Organization did not meet the 33 1/3 percent-of-support test required of a charitable organization in the tax years subsequent to 2005. However, the organization continues to qualify as a publicly-supported organization based on the ten percent-of-support test, and the facts and circumstances as defined in U.S. Treasury section 1.170A-9(f)(3). The Organization is actively pursuing new public support.
