**Valuescience**—taught "Valuescience: Shedding Illusion to Live Better" to thirty-seven Stanford students during spring and autumn quarters, and to more than three hundred people in seminars and meetings at Magic, Stanford, and other local venues; created seventeen thirty-minute valuescience audiovisual presentations that we tested in our Stanford classes and are revising on the basis of student response; advocated a consilient scientific worldview as a fundamental learning objective in interviews for a Palo Alto Weekly article and webcast about home schooling. **Residential Community**—guided forty-two residents from nine countries and nine states in creating valuescience-based service-learning community. **Silicon Valley Barcode of Life**—initiated this project, one of several dozen world-wide initiatives to catalog and track changes in biodiversity using DNA sequencing of specific small genome regions.

Barcode of Life (svbol.org) as part of our valuescience program in 2017. Both revenues and direct expenses during 2017 were less than \$1,00

Part III, Lines 4a and 4b: Magic's programs are integrated, particularly our valuescience-based service-learning community. We've allocated expenses to reflect labor expended by personnel (Magic is operated entirely by volunteers) as well as cash and inkind outlays net of grants. We allocated 60% expenses (excluding grants) to Valuescience, 25% to Cooperation and Individual Well-being, and 15% to Environmental Stewardship.

Part VI, Line 11: At the annual meeting where board members and officers are elected, members of Magic's Board of Directors receive estimates of the financial information and drafts of the program descriptions to be entered on Form 990. Board members receive quarterly or when requested more frequent reports of program activities and finances. Directors are given opportunity to review completed Form 990's before they are submitted. They are informed that Magic also submits Form 199, California Exempt Organization Annual Form, to the California Franchise Tax Board and Annual Registration Renewal Fee Report to Attorney General of California and offered opportunity to review these if they choose. All information on these forms is taken directly from Form 990 and its attachments.
