Ability Tools - is dedicated to expanding the availability of tools, resources and technology that increases independence, improves personal productivity and enhances the quality of life of Californians with disabilities. We support Device Lending Libraries, Reuse Centers and Independent Living Centers throughout the state. We provide funding, training, and technical assistance to a network of over 1600 organizations and individuals. We developed the Freedom Tech Alternative Finance Program to provide low interest loans to people with disabilities and their families who are seeking loans for Assistive Technologies home or vehicle modifications. CFILC also launched a pilot project, Voice Options, to assist individuals who need support in communicating through alternative options.

4b (Code) (Expenses \$ 381,782 including grants of \$) (Revenue \$)

Disability Organizing Network is a focused on organizing for accessible communities. We support statewide and regional organizing campaigns that are driven by local communities. In 2017 we provided educational opportunities on statewide and national health care changes that could impact people with disabilities.

4c (Code) (Expenses \$ 747,013 including grants of \$) (Revenue \$)

Voice Options is a pilot program that assists Californians with speech and language disabilities. This program focuses on using an iPad with five speech applications to help give participants access to a communication device. Voice Options also offers basic training on iPad accessibility features and five speech applications. The Voice Options process starts with a device demonstration, followed by a short-term loan of 14 to 30 days. Then, after successfully completing these steps, the consumer can apply to receive a long-term loan of an iPad with their favorite speech application.
