Farm to Market - CAFF connects farmers and businesses, providing growers with a suite of tools and marketing materials and also coordinating product availability with aggregated purchasing to ensure supply and demand grow together. The Farm to Market program couples consumer education with technical assistance in tracing value through the supply chain. CAFF works with food service leaders to provide staff trainings, education for students, and collaborative purchasing and resource sharing structures. CAFF's Farm to Cafeteria program grows connections between farmers, communities, and institutions. With over 20 years of experience working with local farms and institutions, we are able to help institutional food service operations develop local procurement goals and implement farm to cafeteria programs. In 2017, CAFF facilitated over \$800,000 in sales for California family farms through our initiatives and activities: Good Food Marketplace, Purchasing Collaboratives, Farm Direct, and Farm to School. CAFF Food Safety program, now in its tenth year, continues to provide comprehensive food safety technical assistance across California. Since 2007, CAFF's Food Safety program has reached nearly 3,000 growers and helped over 250 farms develop farmfood safety plans.

We continue that work today by focusing on state and federal policies, defending the rights of family farmers, as well as educating them about new policies that affect their farms. It is CAFF's goal to change the course of agriculture, and to do that we need to influence institutions, commodity boards, state and federal agencies, and legislators who set public policy. CAFF is proud of our history of successful legislative efforts and our policy work. CAFF supported eleven bills that successfully passed through the California state legislature in 2017. Topics ranged from farmland conservancy, to Healthy Soils program funding, to groundwater protection. We will continue collaborating with others in support of climate-smart farming legislation in the years to come.
