The exemptions are subject to periodic review by the federal and state taxing authorities and management is confident that the Center continues to satisfy all federal and state statutes in order to qualify for continued tax exemption status. The Center is not required to file an annual return with the IRS because it is classified (and therefore exempted) as a church. The Center may periodically receive unrelated business income (such as sublease rental income) requiring the Center to file separate tax returns under federal and state statutes. If such conditions were to exist, the Center would calculate and accrue the applicable taxes.
