National program expenditures funded our national campaigns and programs, from organizational support for state affiliates, to policy advocacy, to national educational campaigns. A few highlights were the climate march in DC, where hundreds of IPL-affiliated people joined the faith block and carried banners and signs proclaiming faith support for climate action, policy advocacy in support of the BLMs and EPAs methane emissions standards, our Paris 'Were Still In' campaign to have congregations commit to the carbon cutting goals of the Paris accord, and a new U.S. solar directory of over 400 congregations utilizing rooftop solar, along with resources and recommended solar companies. In 2017 IPL earned over 950 news media mentions and increased our social media presence and reach by about 7%. We regularly communicated with over 86,000 people on our email list and 20,000 congregations.

Form 990, Part III, Line 4b:

The next largest portion of our program expenses was distributed in support grants to state affiliates. State IPLs educated their congregations about global warming, facilitated congregations going green, and advocated for clean energy alternatives to coal, state climate policy, and stronger vehicle emissions standards.

Form 990, Part III, Line 4c:

California Interfaith Power & Light (CIPL) educated its 700 member congregations about global warming and advocated for equitable and effective climate policies at the state level. Highlights of the year included a "Cool Climate Awards" event honoring congregations for greening their facilities and engaging their communities in climate solutions, and a Green Jobs Fair Oakland. The fair was attended by over 80 job seekers and held at a historically black West Oakland church. We also successfully advocated for the renewal of our states climate policy and stronger air quality regulations.
