The funds provided by the Doyle Trust to the City of Santa Rosa are used to maintain Doyle Park, an essential governmental function. The Doyle Scholarships are well-known within the community and have allowed three generations of families to attend the communitys highly rated and highly regarded junior college. The Trustees of the Trust work closely with the District to define and address the Districts needs. In addition to the distribution of funds, the Trust performs important functions on behalf of the Santa Rosa Junior College District that would otherwise be performed by the District, including the implementation, maintenance and operation of the highly specialized and time-consuming Doyle Trustee Awards Program, by which the Trust is solely responsible for the review, selection and award of scholarships to worthy students whose challenges and struggles most likely impeded their academic success in high school and who would not otherwise qualify for merit based scholarships. The Doyle Trustee Awards Program was designed and implemented by the Trustees at the request of the District and addresses a very important need within the community and the District. In doing so, the Trustees sit on and regularly participate in the Districts Scholarship Committee. The Trust also routinely presents the regular Doyle Scholarship Awards on behalf of the Santa Rosa Junior College District at the many high school awards ceremonies within the District. The Trust's activities would have to be carried out by the respective governmental entity but for the involvement of the Doyle Trust.</p>
