The Adventist Health Glendale Foundation provides a fundraising function to support the mission of Adventist Health Glendale and programs to improve the quality of life and health in our community. The funds are transferred to the hospital based on the grantors and donors intent. A significant portion of Management and General expenses are paid for by Adventist Health Glendale and accounted for as a department of the hospital in its support of the Foundation. The following story illustrates how the Foundation is able to support the mission of Adventist Health Glendale and believes it is a miracle in the making. As an infant, Aren began to show signs of disabilities. His parents knew something wasn't right. Into his second year, their son was not developing like other children his age. Aren seemed unaware of his surroundings. His mom and dad struggled to get his attention and to connect with him. He was not beginning to walk or babble. Unable to chew his food or even drink through a straw, it seemed his brain and his body were somehow disconnected. Desperately needing help coping with these challenges, Aren's parents were referred to Adventist Health Glendale's Play to Learn Center, widely recognized for its success with developmentally disabled children. Aren was diagnosed with autism, apraxia of speech and dyspraxia, which limits speech ability and impairs fine and/or gross motor coordination. The center's uniquely skilled physical and occupational therapists, and speech and language pathologists, began working with Aren. Marie Elena Barth was a member of that team. As a former elementary school teacher, she formed a special bond with Aren and his parents. Mom says Marie was Aren's guardian angel. After just two sessions, Marie found that music and singing nursery rhymes were keys to gaining Aren's attention and encouraging him to communicate but she didn't stop there. Eager to find another way for Aren to make his needs and wants known, Marie experimented with using an iPad application. At the time, using the iPad for generating speech was revolutionary and it would change the course of Aren's life. Over time, thanks to intensive intervention provided by occupational therapist Steven Bates, Aren's fine motor skills improved and he became proficient using picture icons and the iPad keyboard to express thoughts and wishes. He was finally able to say to his parents (I) love you. All the while, other outstanding therapists on the center's team were working with Aren. At times, progress was agonizingly slow, but with patience and tenacity, amazing results occurred. When Aren was 7, his parents made an incredible discovery. He could add, subtract, multiply, and divide. He was reading and typing words and sentences, understanding English, Armenian and other languages. Beneath Aren's outer challenges and initial isolation from not being able to speak, his sweet, determined personality and analytical mind shined through, as he communicates with his iPad, sharing the world with others, says Traci Martinez, DPT. Today, at age 8, Aren runs and jumps, eats and plays with his younger brother, just like other kids. Challenges remain, but he is now a successful third grader in a full general education classroom in a Glendale public school. He's studying all the usual subjects, taking tests and playing with his friends at recess. His progress is truly amazing. Aren is already planning his future. He wants to become, in his own words, "A math teacher for kids like me who can't talk but can think because they deserve it, all kids do. I want to teach them the value of numbers so that they can go to the store and order what they want and no one can stop them." Marie Elena Barth passed away in 2017 from cancer. She exemplified the quality of professionals at the Play to Learn Center whose skills and experience are helping children and their families every day. Her colleagues miss her dearly. Compassionate, high-quality patient care, life-saving and life-preserving medical and surgical services, advanced treatments in a community-based hospital, essential emergency services—these are the reasons our donors choose Adventist Health Glendale as their charity of choice.
