The high quality material appeals to amateur and advanced hobbyists, nurseryman, academic botanist and everyone in between. The CSSA has published the Journal since 1929. Recent back issues can be purchased and older volumes can be purchased on DVD.

Haseltonia is the technical yearbook of the Cactus and Succulent Society of America. It is published in full color and features peer-reviewed articles about all aspects of cactus and succulents. Serious students of succulent flora, botanist, taxonomists, researchers and horticulturalist will find Haseltonia valuable addition to their book collection. Back issues are available.

We have also published a book entitled "Beginners Guide to Gasteria, Haworthia, Agave, and other succulent Monocots" by Tom Glavich

The CSSA holds a Convention every other year where members enjoy talks by leading speakers from all over the world. Attendees go on tours to notable cactus and succulent locations in the area. They have the opportunity to purchase rare and unusual plants from vendors. The 2017 Convention was held at the Tempe Mission Palms Hotel in Tempe, Arizona on July 26 to July 30, 2017.
