

CIFOR continued to lead the CGIAR program on Forests, Trees and Agroforestry (FTA) - the world's largest integrated collaborative research program on forests and trees. CIFOR is engaged in two other CGIAR programs - in the IFPRI led Policies, Institutions, and Markets and the CIAT led program on Climate Change, Agriculture and Food Security.

CIFOR has been leading the Global Landscape Forum, a multi-partnership initiative over the last few years. The GLF has grown into a platform that addresses questions about sustainable development, climate change, poverty and gender at various scales.

In 2017, Research Support Units supported CIFOR's research programmes by providing state-of-the-art technical services, library facilities, computer services, systems development, and electronic communications.

In 2017, CIFOR scientists based around the world produced a total of 382 publications, including 204 scientific articles - of which 78% were in open-access journals -- as well as 10 books, 26 book chapters, 35 occasional or working papers, 53 briefs, and 41 factsheets. Our publications were downloaded nearly 1.5 million times, with over 10,000 citations and 400,000 Google book visits.
