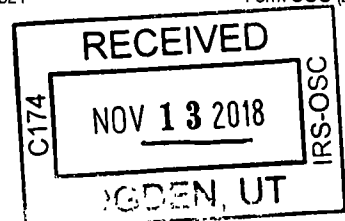

FIND is an international non-profit organization that enables the development and delivery of much-needed diagnostic tests for poverty-related diseases. FIND acts as a bridge between experts in technology development, policy and clinical care, reducing barriers to innovation and effective implementation of diagnostic solutions in low-and-middle-income countries.

FIND's Access programme in India saw significant acceleration in spend in 2017 as all procurement and publication commitments needed to be met before close-out of a big grant. There were 4 main areas of activity in the Access program in 2017, with main accomplishments as follow. i) Market analysis - outputs of this activity serve to inform product development, regulatory and introduction strategies. The highest impact output from this activity was the HCV diagnostics market intelligence report (publically available), outlining elements driving the projections and what factors will allow countries to diagnose more patients. ii) Data aggregation platforms - In India, over 1500 GX instruments were mapped for real-time result reporting into the national surveillance system and electronic patient register. iii) Network mapping - aims to use existing data to better position diagnostics infrastructure and services based on where patients seek care. In India, results were used to engage more private sector providers, and to optimise sample transport and based on instrument placements for early TB diagnosis. In Lesotho, the data were used to determine how best to expand the network and to identify gaps in the care cascade. iv) Capacity building and lab strengthening - in India, 14k MDR-TB cases were identified in FIND-supported labs; 631 lab personnel were trained, a system to solve supply chain issues implemented; significant contributions toward national lab specifications and procurement guidelines. FIND's performance here has allowed it to become a PR for GF India.

4b (Code: TB) (Expenses \$ 9,987,814 including grants of \$ 5,377,967) (Revenue \$ 10,337,055)

The TB R&D program saw significant activity in development phases (pre-validation) in 2017, primarily in the areas of POCT and DST. The two most significant accomplishment in R&D were i) proof-of-principle work for a urine-based POCT with significantly increased sensitivity for use in HIV co-infected patients, this test will go through to development phase in 2018. ii) a host biomarker signature (several markers) that would meet the TPPs for a triage test was validated; this will be transferred to a technology platform in 2018 to assess feasibility of development. The second largest area of activity in the TB programme is clinical work and gathering of evidence for WHO review, so that a recommendation on use can be made. In 2017, FIND contributed evidence to WHO that resulted in 2 recommendations: i) critical concentrations for drug susceptibility testing of medicines used in the treatment of drug resistant TB, and ii) on the use of commercial products for preserving specimens that will be used for diagnosing TB, for improving sputum transportation. Lastly, the TB program's contributions to global guidance (an outcome indicator), were strong in 2017, with 5 out of the 7 outputs that FIND contributed to being for TB in the areas of: i) country transitioning from Xpert MTB/Rif to Ultra; training & practical guidance for diagnostic network strengthening; model diagnostic algorithms, and guidelines for specimen referral.

4c (Code: Fever) (Expenses \$ 6,658,821 including grants of \$ 4,013,052) (Revenue \$ 7,619,520)

Fever management is a new area of work for FIND, as the need for diagnostic tests for malaria become more focused on being suited for use in elimination programs, FIND has started looking at the problem of febrile patients who have a negative malaria test and are likely to be prescribed antibiotics on a "just in case" basis. The primary R&D needs for diagnostics for fever management are clear: a POCT that can differentiate bacterial from non-bacterial fevers, that will enable better initial treatment and referral practices. The most widely used marker is CRP, and while it is sub-optimal, there are no other validated biomarkers for a fever triage test at the moment. Therefore, during 2017, FIND invested heavily in gathering data on the performance of alternate biomarkers. While this is critical for advancing test development, a second significant area of intervention when addressing fever management is behaviour change, both in clinicians and patients. Therefore, in order to better direct its R&D, FIND chose to partner for large scale studies in Thailand to demonstrate the impact of CRP testing on prescribing practice. Results showed that ~14% reduction in the number of patients receiving inappropriate treatment, which translated into 80% of patients receiving appropriate care. Data were shared with the Thai FDA and the Ministry of Health to help shape local policy on test and treat.
