Each five pages of copy paper is approximately one ounce, so staff can first determine the approximate number of pages included in the copy request and then compute the ounces by dividing the total number of pages by five. Once the number of ounces is known, staff can consult current postal rates online at www.usps.gov to provide the request or with an estimate of postal charges. Requests for corporate documents can also be picked up during regular business hours to save the requestor from having to pay postal charges.
