When the hospital is in need of funds, AHC, Inc. issues a preliminary Grant Award Letter. AHC, Inc. then arranges for the purchase and delivery of those supplies to the hospital in Cambodia. The hospital acknowledges the receipt of supplies. AHC, Inc. maintains overview responsibilities of the hospital:

- a. A member of the Cambodian-based hospital's board of trustees is a member of AHC, Inc.'s board.
- b. AHC, Inc.'s President makes annual visits to the hospital where he talks to staff, helps train hospital medical personnel, and assesses conditions and compliance.
- c. AHC, Inc. board members regularly communicate with hospital staff and volunteers.
- d. AHC, Inc. board members review hospital newsletters and Annual Reports.
