Once decision is made, the applicant is made aware of the status of their application. The Selection Committee uses Staples Share Fund guidelines and a Staples Share Fund Grant award list of frequent or commonly requested categories so that award amount decisions remain consistent. If denied, the applicant is provided with the above reason as to why; if approved the applicant is made aware that this grant is in no way a benefit and should not be used to replace or supplement Staples compensation or benefits to its associates, including covering any deductibles from Staples plans or lost wages due to a reduction in hours. All Applicants receive employee assistance program details with their denial or approval letter.
