The organization performs an annual fundraising letter campaign for four all volunteer fire departments located in Borough of Ligonier PA and Ligonier Township PA as follows: Ligonier Volunteer Hose Company #1, Ligonier Township VFD #1 (Waterford), Ligonier Township VFD #2 (Wilpen) and Ligonier Township VFD #3 (Darlington). The campaign raised \$184,076 allowing \$180,000 to be divided the four VFDs for their operations after deducting \$4,876 in direct fundraising expenses.

4b (Code:) (Expenses \$ 225,000. including grants of \$ 0.) (Revenue \$ 225,000.)

Grants were applied for from various funding sources for the construction of an addition to the station housing Ligonier Township VFD #3 (Darlington). During the fiscal year ending February 28, 2018, Ligonier Fire Companies was notified the requests from funding sources had been approved. The funding was forwarded to Ligonier Township VFD #3 (Darlington) upon receipt.

4c (Code:) (Expenses \$ 30,647. including grants of \$ 0.) (Revenue \$ 0.)

Two grants for \$60,000 were received in the prior fiscal year for 99 uniforms for the volunteer fire fighters. A deposit on the uniforms was made that year for \$28,732 plus \$620 for shoulder patches. The balance of \$30,648 was paid in the fiscal year ended February 28, 2018 when the uniforms were received and for badges.
