The Foundation has conflict of interest policies and each Trustee - at the annual Board meeting -- is reminded of that policy and is asked to verify that there are no conflicts. In the future, written documentation will be obtained by each Board member. Regarding 15b - there is no compensation paid to any officer or Board member. Regarding 19, the final Form 990 is provided in hardcopy to each Board member and they can provide copies to whoever asks.
