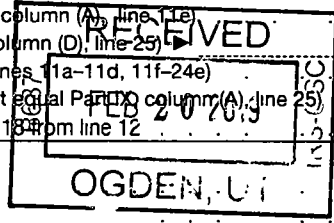

**FINANCIAL SERVICES, TRAINING AND PRODUCT DEVELOPMENT: THE ORGANIZATION OPERATES A MICROFINANCE PROGRAM IN 32 IMPOVERISHED HONDURAN VILLAGES. LOAN RECIPIENTS CONSIST OF POOR, SMALL-YIELD FARMERS. THE ORGANIZATION HELPS THESE FARMERS INCREASE THEIR AGRICULTURAL CAPACITIES. PHYSICAL INPUTS SUCH AS FERTILIZER AND FIELD TOOLS ARE OFFERED TO FARMERS WITHOUT CREDIT HISTORY OR COLLATERAL. CLIENTS ATTEND PAYMENT AND PROGRAM UPDATE MEETINGS EVERY TWO WEEKS.
