Crisis Response - During the fiscal year, TWB deployed its Words of Relief (WoR) language services in support of humanitarian assistance for refugees in Europe, Rohingya refugees in Bangladesh, and displaced communities in northeast Nigeria, among others. WoR is intended to eliminate linguistic barriers that can impede vital response and relief efforts. Through WoR, TWB provided vital information in key languages of affected populations, before, during and after crises occurred. This involved developing a remote network of translators, building translation and interpreting skills locally, providing terminology tools and resources to aid consistent and accurate communication, and using technologies to ensure rapid, high-quality translation response from translation teams and better dissemination of critical content through partners.

Development and Preparedness - TWB development and preparedness programs provide support for non-crisis aid programs worldwide, facilitating effective communication between humanitarian workers and the populations they serve. TWB focuses on the most vulnerable by translating life-saving information and building local language translation capacity for underserved languages or where no translation capacity exists. Most of the development translation work of TWB is delivered through Katã³, the improved and expanded translation platform, formerly known as the Translators without Borders (TWB) Workspace. Katã³ is a managed, crowd-sourced platform connecting the TWB community of qualified volunteer translators directly with non-profit partners. TWB has grown from working in a few core languages to translating 185 language pairs in 2017 and working with over 20,000 volunteer translators via Katã³. In 2017 alone, 148 aid organizations received 11 million translated words to support their projects to amplify the impact of their work.
