Launch Global - Funding is being used to launch teams to work in East Asia and Indonesia. They are equipping teams who are going to these areas for explorations. The funds are also paying translation and development of in-cultural resources, team development and care for those communities. The funds are also providing training for team members, leadership and staff development.

4b (Code: 501) (Expenses \$ 60,000. including grants of \$ 60,000.) (Revenue \$ 0.)

The Farm Project - Funding used to drill 8 wells, provide irrigation system for 8 acres of land, and purchase 8 ovens. All of this was done in Uganda for the Sudanese refugee camps.

4c (Code 501) (Expenses \$ 50,000. including grants of \$ 50,000.) (Revenue \$ 0.)

Red Oak - Funding allowed Red Oak to greatly expand its Holistic care program of counseling, encouragement, and traveling to at-risk, exploited and abused women. These efforts help heal the women from their trauma and develop tools and confidence to live sustainable lives. A professional counselor has been hired to lead group and one-on-one counseling. A larger office with a counseling room was rented to better facilitate healing. Counseling retreats, economic empowerment and job creations and vocational training and professional development courses are being implemented.
