AEP has worked closely with the grantee/staff to promote comprehension of the grant requirements through professional development/coaching and web-based monitoring tools. AEP actively manages programmatic and financial performance to ensure that activities managed by the grantee are implemented properly. The use of grant funds is monitoring monthly through submission of budgets and reports.
