Explanation: In August 2018, it became apparent that the staff person who was maintaining the organization's fiscal records had made multiple errors in maintaining the organization's fiscal records, making the filing of an accurate Form 990 for the fiscal year ending March 31, 2018 impossible. On August 15, 2018, the organization submitted Form 8868 requesting a six-month extension, which was granted. The organization initially attempted to resolve the problems discovered in the financial records internally, but it became apparent that outside help was needed. The organization retained the services of a fiscal consultant who was able to resolve errors in the records. His work was completed in June 2019, at which time the organization completed its Form 990. The organization has taken a number of steps to ensure that the mistakes leading to the late filing of Form 990 will not be repeated, including: * The staff person who had been responsible for maintaining financial records has been terminated. * The position description was revised to place a greater emphasis on fiscal operations, and the position has been filled by a staff member with more experience with maintaining fiscal records. * The organization has revised its procedures to strengthen review and oversight of financial operations and reports by both the organization's executive director and board Treasurer.
