We then work to ensure people have access to necessities including water, food, medicine, shelter, and clothing. Everything we do is built on the belief that we, as people of faith, are called to change lives. And we believe lives can only be changed when the needs of the whole person are met - body and soul. Faith means very little when people don't have access to the food, clean water, or medicines they need. But without faith, meeting those
