THIS NEW MACHINE WILL OFFER TOMOSYNTHESIS, WHICH IS CAPTURING MULTIPLE IMAGES THROUGHOUT THE BREAST, ENABLING RADIOLOGISTS TO BETTER EVALUATE RESULTS. THIS UNIT WILL ALSO ENABLE THE HOSPITAL TO INCREASE THE NUMBER OF MAMMOGRAPHY PROCEDURES BY OVER 20% AND AID IN EARLIER DETECTIONS OF INVASIVE CANCERS. THE PURCHASE OF INFANT SLEEP SACKS ALLOWS THE HOSPITAL TO PROVIDE EACH MOTHER WITH A WEARABLE BLANKET FOR THEIR NEW BABY WHEN THEY ARE DISCHARGED.
