Core Title X family planning services include reproductive life plan counseling (or education on pregnancy planning or prevention), contraceptive services, pregnancy testing and counseling, help achieving pregnancy, basic infertility services, HIV screening, STI testing and treatment and preconception health services. WHFPT provided funding to 28 agencies and 94 service sites during the year ended March 31, 2018. In the fifth year of its Title X Project WHFPT, through its subrecipient agencies, provided Title X funded family planning and related services to nearly 195,000 low-income and uninsured Texans.
