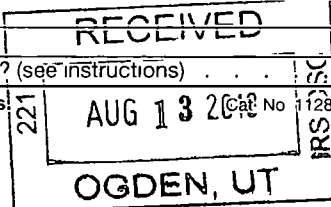

PAN works to build health, justice and resilience in our food and farming system. As one of five PAN Regional Centers worldwide, we link local and international consumer, labor, health, environment and agriculture groups into a citizens' network that challenges the global proliferation of pesticides, defends basic rights to health and environmental quality, and works to ensure the transition to a just and viable food and farming system.

Core programs: PAN has campaign activities in four key agricultural states, as well as national and international programs. Our state campaigns in California, Hawai'i, Iowa and Minnesota use coalition organization, strategic communications and grassroots science to raise awareness about pesticide harms and build public will for a healthier food and farming system. In 2017-2018, our successes included 1) winning new rules in California to ensure farmers of color have access to resources for sustainable farming; 2) mobilizing farmers in Iowa to challenge registration of the new herbicide dicamba, which damaged more than 3.5 million acres of non-GE soy and millions of acres of other crops in 20 states; 3) building momentum for state and national-level protections from the brain-harming pesticide chlorpyrifos, including legal action, introduction of national legislation and progress in our key states.

Coalitions: PAN North America builds network power through strategic alliances with other public interest organizations. As the U.S.-based Regional Center of an international network, we facilitate collaboration among more than 150 organizations in North America, linked to some 600 groups in more than 90 countries worldwide. Often, our campaigns with network partners lead to creation of formal coalitions for which PAN serves as facilitator, administrator and/or fiscal sponsor. The most significant coalition sponsored in 2017-2018 was Californians for Pesticide Reform (CPR). This vibrant coalition includes 190 groups across the state, and PAN is one of the leading members in policy advocacy for children's health and farmworker protection. Our coalition in Iowa is also strong and active, with five farmer-led organizations and PAN forming the core. Having focused on issues of crop damage from herbicides for several years, this group was well positioned to support farmers document the on-farm impacts of the dicamba drift crisis during last year's growing season. PAN also supported coalitions and advocacy networks in Hawai'i and Minnesota, and participates in coalition work in Colorado, Maryland and nationally.
