PLANT SCIENCECalifornia is increasingly impacted by fire, climate change, and the growing biodiversity crisis. Science is fundamental to finding enduring solutions. The CNPS Plant Science Division had an incredibly productive year, making important discoveries and much-needed advances. We found and mapped rare plants, seed banked rare species as a hedge against extinction, and advanced the ambitious effort to map all of Californias natural communities. CNPS launched ReOak California in partnership with dozens of partners, this project engaged 1,000 volunteers to collect 150,000 acorns, and was heard of by approximately 1M Californians. We researched cutting-edge science to publish the Guide to Recovery After Fire, distributing more an 22K copies to landowners in need. Bureau of Land Management, the US Forest Service, and other State and Federal agencies funded CNPS science to develop hundreds of rare plant species profiles for national forest planning, conduct climate change mapping in federal monuments, and complete dozens of field surveys. The team contributed to Important Plant Areas work, securing and analyzing data to identify Californias most irreplaceable biodiversity hotspots.

These groups bring the CNPS mission to life in our communities, hosting native plant garden tours, field trips, operating nurseries and plant sales, conducting botanical surveys, and advancing local conservation action. They provide consultation to watershed and education groups in their communities, and educational talks up and down the state. The amazing volunteers gave their time at local nurseries, schools, and community groups to improve nursery practices, start public gardens, help their neighbors convert water-hungry lawns to natural landscapes, and more. CNPS chapter volunteers also served a critical need in their communities by helping to remove invasive species and restore landscapes at local and regional parks. Donations and bequests that support CNPS make it possible to grow and nurture a community of engaged Californians that continue, after 52 years, to be one of the greatest forces for positive change and thoughtful stewardship in the Golden State.
