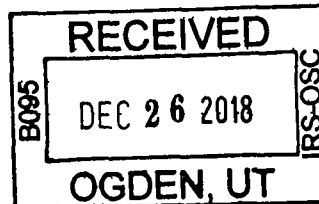

THEREFORE, THERE IS NO VALUE BEING CARRIED ON THE BOOKS. FURTHER, THE BUILDINGS WERE BUILT AFTER THE LAND BECAME THE POSSESSION OF THE ORGANIZATION. NO RECORDS EXIST FOR BASIS OF THE BUILDINGS NOW IN EXISTENCE ON THE PROPERTY. IN ANY EVENT, THE BASIS WOULD BE ZERO AT THIS POINT, HAVING BEEN DEPRECIATED OR DEPRECIABLE OVER THE YEARS.

THE ORGANIZATION WAS FORMED IN 1945 AS AN ASSOCIATION, FILING THE ARTICLES OF AGREEMENT WITH THE NH SECRETARY OF STATE'S OFFICE. PRIOR TO THAT IT HAD SERVED THE LOCAL COMMUNITY AS A CLUB SINCE 1925. THE ORGANIZATION RECEIVED ITS 503(C)(7) STATUS APRIL 27, 1973. IT IS UNKNOWN HOW MUCH DETAIL WAS REQUIRED WHEN THE ORIGINAL EXEMPT STATUS WAS GIVEN. TODAY, THE ORGANIZATION IS ORGANIZED FOR THE SAME OVERALL GENERAL PURPOSES OF PROVIDING AN OUTING CLUB FOR ITS MEMBERS FOR THE VENUE OF SHOOTING SPORTS. IT OFFERS PROGRAMS FOR THE MEMBERS AND ALSO LIMITED PROGRAMS FOR THE COMMUNITY. THE ORGANIZATION HAS ONCE RESTRICTED FUND SET UP OFFER SCHOLARSHIPS FOR THE BENEFIT OF YOUTHS TO ATTEND THE 4-H BARRY CAMP OFFERED THROUGH THE UNIVERSITY OF NEW HAMPSHIRE CO-OP EXTENSION SERVICE. THE FUNDING FOR THE ORGANIZATION COMES PRIMARILY FROM MEMBERSHIP DUES AND PROGRAM SERVICES OFFERED. ALL OF THIS MAY HAVE BEEN DISCLOSED TO THE INTERNAL REVENUE SERVICE PREVIOUSLY. HOWEVER, BECAUSE IT IS UNKNOWN, IT IS BEING DISCLOSED WITH THIS RETURN.
