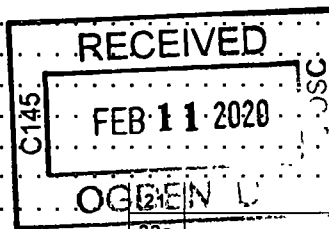

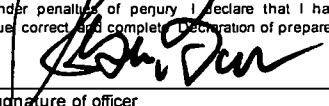

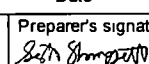

AJWS IS AMENDING THEIR 990-T TO ACCURATELY REFLECT THAT THEY DO NOT HAVE ANY UNRELATED BUSINESS INCOME.
