The Center's programs catalyze innovation in the forest economy to create jobs and build local wealth through market-based economic opportunities that advance a regional land ethic and sustainable use of the forest. Accomplishments include:

I. Automated Wood Heat: In FY17, the Center provided incentives for 17 new automated wood pellet boiler installations in New York and Vermont. With ongoing programs in New Hampshire and Maine, the program generated more than \$597,000 of positive impact for the regional economy for the year, and brought the program's total economic impact to more than \$2.4 million. By switching participants from fossil fuels to renewable wood pellets for heat, this program reduced greenhouse gas impact by 866

The Center's Regional Leadership programs empower local voices and initiatives, and advocate a regional vision for thriving communities and healthy forests.

I. Community Capacity and Leadership: The Center provides research, project management, network facilitation, financing, regional economic and community best practices, and more to connect and support regional leaders who are working to adapt to economic, social and other changes. In FY17, we worked intensively with local business leaders in Maine, Vermont and New York to prepare major economic investment projects for potential tax credit financing to generate jobs, retained investment and other benefits for local communities. Through five project

The Center's new Community Revitalization program engages targeted communities in identifying and investing in projects that can enhance community vitality and attract entrepreneurial people and families.

I. Community Forests: The Center helps communities purchase and manage forests that generate economic and community benefits while conserving the forest base in perpetuity. In FY17, the Center helped the community of Milan, N.H. expand its new Community Forest by 1,128 acres; provided technical assistance and capacity building to the town of Bethel, Maine, as residents explored the feasibility of creating a new Community Forest to serve the town's recreation needs and other purposes; and assisted two communities in New York in researching and

Vermont, and provided technical assistance to three new wood heating projects including fuel conversions for the Rialto Theatre in Lancaster, NH and the New England Outdoor Center in Millinocket, Maine, and a potential new pellet mill in the Northeast Kingdom of Vermont.

II. Wood Products Manufacturing: In FY17, the Center provided technical and financial assistance to 16 wood products manufacturers to implement innovations to transform their businesses to help sustain and create quality jobs in the region. The Center spurred \$361,000 of financial investment in the region's wood products companies during the year, and has leveraged nearly \$1.56 million worth of investment in this important employment sector through innovation incentives since the program began. Companies have implemented lean manufacturing systems and addressed critical issues in organizational and financial management and leadership succession. In FY17, the Center also advanced woodworker training by enrolling 61 people in wood worker skills certification programs in Maine and New York-based educational programs in partnership with the Woodwork Career Alliance. Assistance from the wood products program in FY17 helped companies retain or create jobs for more than 500 people.
