The primary goal of all Childrens Advocacy Centers is to ensure the children disclosing abuse are not further victimized by intervention system designed to protect them. CAC are child-focused, facility-based programs with representatives from many disciplines working together to effectively investigate, prosecute and treat child abuse. CAC locations are not only child-focused, but designed to create a sense of safety and security for child victims. The director submitted the application for accreditation for the Cornerstone Child Advocacy Center. A site visit was held in March 2016 by national reviewers and they recommended accreditation for the Cornerstone Child Advocacy Center

Parents as teachers is a strong evidence-based home visiting model providing a broad context of parenting education and family support, and building protective factors, especially for those families in vulnerable situations. At its core Parents as Teachers is relationship-based and parenting-focused. Our approach and curriculum focus on parent-child interaction, development-centered parenting, and skills well being on strengths, capacities, skills and on building protective factors within the family. Parents as Teachers serves a range of families with high needs-not just first time parents-and offers services throughout the continuum from prenatal to kindergarten entry
