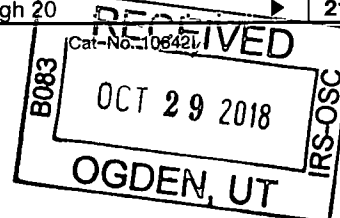

Form 990-EZ, Part III - Organization's Primary Purpose

The Links, Incorporated is an international public service organization of 14,000 women that provide a chain of friendship and community service in 280 chapters located in 41 states, the District of Columbia, Nassau, Bahamas, Frankfurt, Germany, and the South Africa Southern Region. In 1975, a group of women in Normal and Champaign, Illinois became interested in beginning a new chapter. On November 3, 1975, The Normal-Champaign Chapter was chartered. In April, 1996, the chapter name was changed from the Normal-Champaign Chapter to The Links Incorporated Central Illinois Chapter ("Organization") to accurately reflect its members and the following service areas: Bloomington-Normal, Champaign-Urbana, Charleston, Decatur, and Springfield.
