The organization focuses on education, cultural enrichment, health & wellness, and civic involvement.

Provide scholarships to college bound high school seniors and stipends for student tutors/mentors. Each year, Bucks County high school seniors are invited to apply for the Links scholarship, which is a \$2,000 renewable scholarship for four years. A selection committee reviews the applications for academic success, community service and leadership. In the current program year, the chapter awarded scholarships ranging between \$1,000 - \$2,000 for Bucks County students attending colleges in the United States. The chapter also supports high school students at the Kuntu Village in Ghana, West Africa by funding tuition/boarding fees in the amount of \$450 per student. Kuntu Village is a small impoverished village with an unemployment and literacy rate of approximately 90%. The Bucks County Chapter partners with Kuntu Village Nkosohen Committee to provide tuition support, school supplies, tutoring and curriculum development.

The Services to Youth/Youth Council platform is designed to address critical issues which impact youth. Approximately 50 youth attended the "March for Our Lives" rally in DC to join the movement for stopping the epidemic of gun violence in the current program year. The mission of the Youth Council is train teens to become engaged and meet the challenges in their communities and social backgrounds. Youth council participants include youth between the ages of 13-18.
