This festival lasts approximately 8 days, with programs in Portland, Brunswick, Lewiston, Waterville, Bangor and Rockland. Approximately 3000 film goers attend. In addition to the film festival in March, the organization also organizes various film events in the fall and spring and works with schools to present festival films in educational environments.
